41.1 VILLAGE OF WEST CARTHAGE

This jurisdictional annex to the Jefferson County Hazard Mitigation Plan (HMP) provides information to assist public and private sectors in the Village of West Carthage with reducing losses from future hazard events. This annex is not guidance of what to do when a disaster occurs; its focus is on actions that can be implemented prior to a disaster to reduce or eliminate damage to property and people. The annex presents a general overview of West Carthage, describes who participated in the planning process, assesses West Carthage's risk, vulnerability, and capabilities, and outlines a strategy for achieving a more resilient community.

41.2 HAZARD MITIGATION PLANNING TEAM

The Village of West Carthage identified primary and alternate HMP points of contact and developed this plan over the course of several months, with input from many Village departments.

41.3.2 Community Profile

The Village of West Carthage has an area of one square mile and is located in the central eastern part of the County. The Village is located within the Town of Champion, which is bordered by the Town of Wilna and Town of LeRay to the north, Lewis County to the east and south, and the Town of Rutland to the west. Numerous state highways run directly through the Village of West Carthage.


According to the U.S. Census, the 2020 population for the Village of Carthage was 1,780 which makes up 1.5 percent of the county population. Data from the 2022 American Community Survey indicates that 5.7 percent of the population is 5 years of age or younger, 17.1 percent is 65 years of age or older, 1.5 percent is non-English speaking, 10.6 percent is below the poverty threshold, and 13.1 percent is considered disabled.

41.4 JURISDICTIONAL RISK ASSESSMENT

The hazard profiles in Volume I provide detailed information regarding each planning partner's vulnerability to the identified hazards, including summaries of West Carthage's risk assessment results and data used to determine the hazard ranking. Key local risk assessment information is presented below.

Each jurisdiction has unique assets, vulnerabilities and overall risk. A multi-jurisdictional plan needs to identify every hazard (from the whole planning area). In hazard mitigation planning, risk is the potential for damage or loss when natural hazards interact with people or assets. These assets may be buildings, infrastructure or natural and cultural resources. A risk assessment is a robust, data-driven analysis. It explains what might happen. It also finds where the local jurisdiction is vulnerable to hazards.

Each community must describe how the selected hazards affect its jurisdiction. Some hazards will have similar effects across the area: extreme temperatures, windstorms, winter weather, drought, heavy rain, etc. Some have a smaller location and will vary based on geography. Multi-jurisdictional plans must explain these differences.



Risk is the relationship, or overlap, between hazards and community assets. The smaller the overlap, the lower the risk.


41.4.1 Hazard Area

41.4.2 Previous Event History

The history of natural and non-natural hazard events in West Carthage is detailed in Volume I, where each hazard profile includes a chronology of historical events that have affected the County and its municipalities. Table C provides details on loss and damage in West Carthage during hazard events since the last hazard mitigation plan update.

41.4.5 Hazard Ranking

The participating jurisdictions have differing degrees of vulnerability to the hazards of concern, so each jurisdiction ranked its own degree of risk to each hazard. The community-specific hazard ranking is based on problems and impacts identified by the risk assessment presented in Volume I.

The ranking process involves an assessment of the likelihood of occurrence for each hazard; the potential impacts of the hazard on people, property, and the economy; community capabilities to address the hazard; and changing future climate conditions. Impacts from a particular hazard may have decreased due to an implemented project or relocation of an asset that was previously at risk. Alternatively, risk may have increased because population has increased in a hazard prone area.

At least two of the claims must have occurred within any 10-year period, more than 10 days apart.

41.7 JURISDICTIONAL CAPABILITY INVENTORY AND ASSESSMENT

West Carthage performed an inventory and analysis of existing capabilities, plans, programs, and policies that enhance its ability to implement mitigation strategies. Volume I describes the components included in the capability assessment and their significance for hazard mitigation planning. The jurisdictional assessment for this annex includes analyses of the following:

- Planning and regulatory capabilities
- Development and permitting capabilities
- Administrative and technical capabilities
- Fiscal capabilities
- Education and outreach capabilities
- Classification under various community mitigation programs
- Adaptive capacity to withstand hazard events

For a community to succeed in reducing long-term risk, hazard mitigation must be integrated into day-to-day local government operations. As part of the hazard mitigation analysis, planning and /policy documents were reviewed and each jurisdiction was surveyed to obtain a better understanding of their progress toward plan integration. Development of an updated mitigation strategy provided an opportunity for West Carthage to identify opportunities for integrating mitigation concepts into ongoing Village procedures.

41.7.1 Planning and Regulatory Capability and Integration

Planning and regulatory capabilities are the plans, policies, codes, and ordinances that prevent and reduce the impacts of hazards.

Ordinances

Jefferson County has an Emergency Management Ordinance which charges the County with maintaining a Comprehensive Emergency Management Plan to identify local measures that may prevent disasters, to develop local mechanisms to coordinate local resources and personnel for service during and after disasters, support the facilitation of delivery of services to aid citizens and reduce human suffering resulting from disaster, and to provide for short- and long-term recovery and redevelopment after disasters.

Jefferson County has Site Plan and Subdivision Codes that are relevant to development within a certain distance of County interests. Development applications in the areas across the County are sent to County Planning for review to promote coordination of land use decisions and local/county impacts. These County capabilities are inclusive of West Carthage and the jurisdiction often partners with the County. To learn more about these capabilities please see Jefferson County's Jurisdictional Annex.

The HMP Team inventoried its existing ordinances against the full capability list of hazard mitigation-related capabilities. The absence of other kinds of ordinances was not considered a gap in local capabilities. The table below summarizes the ordinances currently in place in the Village.

41.7.2 Administrative and Technical Capability

Jefferson County Code, Fire Prevention and Building Code department currently enforces the New York State Uniform Fire Prevention and Building Code in 31 municipalities that chose not to enforce the Code at the local level, including the Village of West Carthage. The Department employs Code Enforcement Officers and clerical staff to ensure that new construction and areas of public assembly conform to the provisions of the State Uniform Code. Proper enforcement of the Code protects property and encourages quality development that enhances public safety and the economy of the County. The office's two major program responsibilities include existing and new building permit administration (i.e.: plan review, issuing permits, construction inspections and issuing certificates of occupancy) and mandated fire safety inspections.

Jefferson County has an Economic Development Commission (Jefferson County Comprehensive Economic Development Strategy); Emergency Management (Jefferson County Office of Fire & Emergency Management), County Department of Planning; County Public Health Department (including Administration and Finance, Home Healthcare Services, Medical Examiner's Office, Emergency Medical Services); County Highway Department,

among others, whose programs and services serve the entire County, including the Village of West Carthage. To learn more about these capabilities please see Jefferson County's Jurisdictional Annex.

41.8 MITIGATION STRATEGY AND PRIORITIZATION

41.8.1 Past Mitigation Action Status

41.8.3 Identified Issues

The Village of West Carthage has identified the following vulnerabilities within their community for mitigation strategy development:

- The Village building has had the police station, and a garage added and is within the Village with an
 undersized generator. The facilities are unable to perform continuity of operations during power outage events
 as the generator is severely undersized after the upgrades. The facilities can also act as an emergency
 temporary shelter with the addition of a proper sized generator.
- Recent storm events have resulted in severe rainfall which overwhelmed drainage and roadways which
 caused flooding. There are numerous roadways located in the Village that are of infrastructure and flooding
 concerns including Getman Park drainage, Franklin Street culverts, lower Jefferson Street stormwater catch
 basins and sewer lines, lower Liberty Street culvert, and lower Lathrop Street drainage. The Village knows
 that other roads and culverts may also need to be upsized and mitigated.
- Frequent flooding events have resulted in damage to residential properties. These properties have been
 repetitively flooded as documented by paid NFIP claims. The Village has one repetitive loss property, but
 other properties may be impacted by flooding as well.

41.8.4 Proposed Hazard Mitigation Actions for the HMP Update

West Carthage participated in the mitigation strategy workshop and identified hazard mitigation actions to reduce the risks and impacts of hazards the community ranked as high-risk. Hazard risk ranking was specific to each community in the County and was based on quantitative (i.e, analysis of the best available data) and qualitative risk assessment processes (i.e., evaluation of previous occurrences, likelihood of future occurrences and vulnerabilities to people and community services; buildings and critical infrastructure; the natural environment and other local priorities.

Implementation of these actions are dependent upon available funding (grants and local match availability) and local capacity and may be modified or omitted at any time based on the occurrence of new hazard events and changes in local priorities.

Volume I identifies fourteen evaluation criteria for prioritizing the mitigation actions. Below, Table U provides the prioritization criteria score for each proposed mitigation action.
